1 Name

This determination is the *Public Service (Subsection 24(1)—Office of National Intelligence Non-SES Employees) Amendment Determination 2023/01*

Schedule 1—Amendments

Public Service (Subsection 24(1)—Office of National Intelligence Non-SES Employees) Determination 2022/01

1 Section 9

Repeal the section, substitute:

9 Second annual adjustment of salary and allowances

- (1) Subject to subsection 9(3) and 9(4), employees' salaries are adjusted by way of an increase of 3%, with effect on 4 May 2023
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) On this occasion, the salary adjustment set out in subsection 9(1) will also apply to all employees, including where
 - an employee's salary immediately before the adjustment in subsection 9(1) exceeds the salary set out in Column 2 of Schedule 2 for the pay point applicable to the employee, and
 - b the adjustment to the employee's salary in subsection 9(1) will result in the employee's salary exceeding the salary set out in Column 3 of Schedule 2 for the pay point applicable to be employee.
- (4) The Corporate Responsibility Allowance and Restriction Allowance are adjusted by way of an increase of 3%, with effect on 4 May 2023
- (5) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (4)
- (6) Schedule 2 has effect.

2 Schedule 2

Repeal the Schedule, substitute

Schedule 2— Second annual adjustment—Salary and allowances on 4 May 2023

Note See section 9

1 Salary

On 4 May 2023, the salaries set out in column 2 of table 1 below are payable at the rate for that pay point (the new rate) described in column 3 of the table. This is an adjustment by way of an increase of 3% under subsection 9(1) of the Public Service (Subsection 24(1) – Office of National Intelligence Non-SES Employees) Determination 2022/01

Where the base salary of an employee before the commencement of this determination does not appear in Column 2, the salary for that employee will also be adjusted by way of an increase of 3%, applicable on 4 May 2023.
